FORBES' annual Fast Tech 25 list is about finding the firms with superior growth (both past and projected), along with a solid earnings-quality score from Value Line. Forbes evaluated more than 5,000 publicly traded technology companies, looking for profitable companies with a minimum revenue of \$150 million and a minimum market value of \$500 million. They also assessed firms with sales growth of at least 10% for each of the past three fiscal years and over the latest 12 months.

The final list is ranked by trailing three years of revenue growth. Fifteen companies on the Fast Tech 25 had less than \$1 billion in sales over the last year, as well as some large companies with stellar growth such as Facebook, Amazon and Alphabet. Synchronoss which ranked #7, was featured as a company with a three-year average sales growth of 29%
